### Show Cause Notice

Whereas, recognition/permission was granted to the institution **Shri Babasaheb Gharfalkar College of Physical Education, road, Pulgaon, Dist-Wardha** for conducting **B.P.Ed. course** of two year duration vide order No. **WRC/5-6/16/99/4659-4663** dated **04.08.1999** with an intake of **50** students.

And, whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 01.12.2014.

2. And, whereas, the institution by a notarized affidavit dt. **10.03.2015** consented to come under new Regulations and sought for **one basic unit** of two years **B.P.Ed. course** which required additional facilities.

3. And, whereas, it was decided to permit the institution to have **one basic unit of 100 students**, subject to the institution fulfilling following conditions, namely:

- I. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by **October 31<sup>st</sup>, 2015**.
- II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before **October 31<sup>st</sup>, 2015**. Building Completion Certificate (BCC) may be given along with other documents if available; otherwise it can also be given to the Visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by **October 31<sup>st</sup>, 2015**. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- IV. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted along with the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.

And, whereas, in light of the above and in accordance with the **NCTE Regulations, 2014, the Western Regional Committee (NCTE) issued the revised recognition order to Sudam Shikshan Prasarak Mandal's Balasaheb Gharfalkar College of Physical Education, Nachangaon Road, Pulgaon, Dist Wardha Maharashtra, Dated 31.05.2016 for conducting B.P.Ed. course of two years duration with an annual intake of 100 students (one basic unit of 100 students) from the academic session 2015-16 subject to fulfillment of the above conditions.**


And, whereas, the date for compliance regarding faculty was extended by the NCTE Hqrs. upto 29<sup>th</sup> February, 2016 and for additional built up area and addl. FDRs in the joint name, upto 30<sup>th</sup> May, 2016.

And, whereas, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255<sup>th</sup> meeting held on 22-24 June, 2016 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

And, whereas, it has been found from the record that the Institution has not submitted the following documents in compliance of the conditions mentioned in the revised order:

1. Staff Profile for the session 2015-16 duly approved by the affiliating body.
2. Originally notarized CU/NEC/BP and Building Completion Certificate.

In compliance of the decision of the WRC, the Show Cause Notice is issued to the institution under Section 17(1) of the NCTE Act, 1993. The institution is directed to submit written representation within a period of **21** days from the date of this Notice. In the event, this office does not receive any reply, it will be presumed that the institution has nothing to say and the Regional Committee shall take action for withdrawal of recognition.
