### SHOW CAUSE NOTICE

WHEREAS, recognition was granted to the institution namely, IDIAL INSTITUTE OF EDUCATION, RUN BY - GURU AANCHAL SANSTHAN, KHASRA NO.232, POSTI KHANA, FORT ROAD, GWALIOR, MADHYA PRADESH under section 14/15(3)(a) of NCTE Act, 1993 for conducting D.ED course of two years duration with an annual intake of 50 students vide order dated 27.10.2008.

AND WHEREAS, institution has applied for shifting of premises on 10.12.2013 at KHASRA NO.871, NAYA GAON GUDER, TEHSIL/TALUKA - KHANIYA DHANA, TOWN/CITY - NAYA GAON GUDER, DISTRICT - SHIVPURI, MADHYA PRADESH, PIN CODE - 473990..

AND WHEREAS, the matter was placed in the 255<sup>th</sup> WRC meeting held on June 22-24, 2016 and the Committee observed that, "...The institution has applied for shifting of premises. An examination of the documents submitted shows that they are not in accordance with Clause 8(11) of NCTE Regulations, 2009 and Clause 8(9) of the NCTE Regulations, 2014. Hence, Show Cause Notice be issued on the above grounds." Accordingly, Show Cause Notice was issued on 01.07.2016.

AND WHEREAS, institution has again applied for shifting of premises on 03.08.2016 at a different address i.e. KHASRA NO. 65/1/k/1, 65/1/k/2, 79/1/k/min-1, VILLAGE - RAI, DISTRICT - GWALIOR, MADHYA PRADESH.

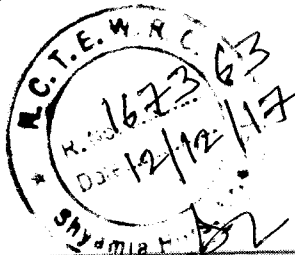
AND WHEREAS, the matter was placed in the 260<sup>th</sup> meeting of WRC held on October 13-15, 2016 and it was decided that, "...The institution applied for shifting on 02/12/2013. VT be constituted. The VT should obtain from the management notarized copies of the relevant documents."

AND WHEREAS, the inspection of the institution was conducted on April 6-7, 2017.

AND WHEREAS, in order to systematize the compilation of complete information of all TEPs in the country, the NCTE HQrs New Delhi had asked all institutions to submit the Mandatory Affidavit on the prescribed format. The first such Public Notice was issued on 05.10.2016. Further opportunity was given on 16.06.2017, and the last date for submission was 12.09.2017. NCTE Delhi also issued Show Cause Notice through PUBLIC NOTICE to submit the Mandatory Affidavit within the specified date. Then, it compiled the list of institutions and identified TEIs which had not complied with the submission of Mandatory Affidavit. The lists were sent to the WRO to reconcile the discrepancies with regard to the address as well as duplication of entries for placing the list to WRC for initiating the process of de-recognition of such institutions. These lists were tabled during the meeting.

The WRC perused the lists as provided by the HQrs as well as the details provided by the WRO.

Thereafter, the WRC decided to issue Show Cause Notice u/s 17 of the NCTE Act for non-compliance of the directions of the NCTE, and why the institution should not be de-recognized. The reply should be sent on or before 23<sup>rd</sup> October 2017 after which further necessary action will be taken as per the Regulations." Accordingly, Show Cause Notice was issued on 06.10.2017.

AND WHEREAS, the original file, visiting team and other relevant documents were considered by WRC in its 283<sup>rd</sup> Meeting held on November 14-15, 2017 and the Committee decided that "...This is a case of shifting. VT report was perused and the CD was seen. The CD shows a building with adequate infrastructural and instructional facilities. The VT has recommended the case. Before the case needs to be processed further, the institution is required to submit the following:-

- (a) Latest premium paid receipt of CLU.
- (b) Latest staff profile duly approved by the affiliating body; and
- (c) Remaining FDR of Rs.4.00 lakhs in original.

**Hence, Show Cause Notice be issued on the above points. Reply should be submitted within one month."**

NOW THEREFORE, in exercise the powers of vested with the Western Regional Committee an opportunity is hereby given to the said institution for making a written representation within 30 days of the issue of this notice before rejection of permission for change of premises on the grounds mentioned above


