

SHOW CAUSE NOTICE

WHEREAS, recognition was granted to the institution, namely, VIRANGANA AWANTIBAI MAHAVIDYALAYA, MAHARSHI ASTANG MEDICAL ORGANISATION, NR CIRCUIT HOUSE, BUS STAND ROAD, JAWAHAR MARG, CHHAFTARPUR, MADHYA PRADESH MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.Ed. (CO-ED).course vide order dated 13-05-2005 for an annual intake of 100 students.

AND WHEREAS, Shri Dayaram Choudhary filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The said W.P. was clubbed with the PIL filed by Shri Pawan Dabey, wherein the Hon'ble Court had directed to conduct inspection of all B.Ed. institutions. The inspection of the institution was conducted u/s 13 by NCTE Hqrs.

AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 29-01-2015.

AND WHEREAS, Revised Recognition order was issued to the institution on 31.05.2015.

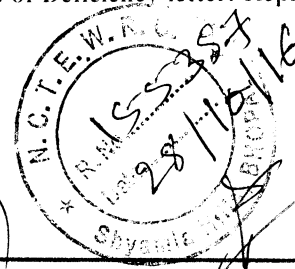
AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on 25.03.2015.

AND WHEREAS, the Deficiency Letter was issued by the NCTE Hqrs. to the institution on 27.07.2015 and the reply of Deficiency Letters was not submitted by the institution till date.

AND WHEREAS, the matter was placed in 260th meeting of WRC held on October 13-15, 2016 and the Committee decided that "...Deficiency letter was issued on 27/07/2015. However no reply has been received so far.

1. You are directed to explain as to why the institution has not maintained Endowment and Reserve Funds both the Funds in a Joints Account with Regional Director, WRC.
2. You are advised to augment resources in the Science Lab, specially by adding mathematical equipments and materials.
3. You are advised to improve service conditions of the staff by introducing approved Pay scales and other benefits like CPF.
4. You are advised to set up the Art and Craft Resource Center.
5. You are required to explain as to why the institution pays salary to staff in cash.
6. You are advised to improve the academic environment of the institution by preparing and implementing annual Institutional Development Plan including organization of Seminars, Conferences, extension lecturers etc.
7. You are advised to submit application for Assessment and Accreditation by NAAC in the session 2015-2016.
8. You are advised to update the website of the institution periodically in the light of NCTE prescribed norms. A print of the latest revision be furnished.

Hence, Show Cause Notice be issued on the points of Deficiency letter. Reply should be submitted to the WRO within 15 days."

Now, therefore this Show Cause Notice is issued u/s 17 of the NCTE Act, 1993 for submission of reply along with supporting document. Your written representation should reach this office within **15 days** from the date of this Notice. In case no representation is received within the stipulated time, it will be presumed that you have nothing to offer and in that event, the WRC shall taken action for withdrawal of recognition u/s 17 of the NCTE Act, 1993.


