SHOW CAUSE NOTICE

WHEREAS, recognition was granted to the institution, namely, **ANNIE BESANT COLLEGE, RAJENDRA NAGAR, 47-48 PRECANCO COLONY, ANNAPURNA ROAD, INDORE MADHYA PRADESH** under section 14 of NCTE Act, 1993 for conducting **B.ED. (CO-ED)** course vide order dated **19.04.2009**

AND WHEREAS, letters dated **20.10.2011, 29.10.2011 & 09.11.2011** were received in this office from the Commissioner, Higher Education, Bhopal, M.P.

AND WHEREAS, the matter was placed in the **162nd WRC Meeting** held on **May 10, 2012** and it was decided to issue Show Cause Notice to the institution based on the points given in the report of the Higher Education Department.

AND WHEREAS, in terms of under section 17 of the NCTE Act, the SCN was sent to institution on **31.05.2012** and the reply was received in WRC on **29.06.2012**.

AND WHEREAS, reply to the show cause submitted by the institution was placed before WRC in its **176th WRC Meeting held on December 20-22, 2012** and the Committee decided that "... A committee authorized by the Higher Education Department, Govt. of M.P. inspected the college. The Committee noted the following shortcomings – Principal and other lecturers are not as per NCTE norms, but no reasons have been given for this observation.

A Show Cause Notice was issued to the institution dt. 31.5.2012 and reply was received vide letter dt. 23.8.2012 saying that all its staff is as per NCTE norms. The case file was examined along with the list submitted by the institution. The Principal and the lecturers have qualification, as per NCTE norms. Hence no further action is needed in this case."

AND WHEREAS, one Shri Pawan Dubey had filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court had directed to inspect all B.Ed. institutions in the State of Madhya Pradesh. Since, the institutions are existing institutions, the inspection was to be conducted by NCTE Hqrs. u/s 13 of the NCTE Act.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on **19.01.2015** and the reply was received on **09.01.2015**.

AND WHEREAS, Revised Recognition order was issued to the institution on **31.05.2015**.

AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on **08.01.2015**.

AND WHEREAS, the Deficiency Letter was issued by the NCTE HQRs. to the institution on **11.05.2015** and the reply of Deficiency Letter was received in NCTE HQRs. on **27.07.2015**.

AND WHEREAS, the VTR/letter was received from NCTE Hqrs. in WRO on **12.11.2015**.

AND WHEREAS, the matter was placed in 237th Meeting held on December 21-22, 2015 of WRC and the Committee decided that "...The reply of the institution was examined in the context of the points raised in the inspection report of the NCTE hqrs conducted under section 13 of the NCTE Act, 1993.

The inspection report under the para headed land and building states as follows:-

"...This means that Krishna Coaching Institute is co-owner of the land. There is a lease deed agreement registered in March, 2007. As per this lease agreement Shri P.K. Yadav has leased property bearing plot No.48-49 at Precanco Colony (14 rooms at ground floor) to Naryan Das Yadav Shiksha Prasar Samiti. The lease is valid for a period of 30 years w.e.f. 28.03.2007. From the Recognition order dated 19.04.2009, it is observed that Recognition granted under clause 7(11) of NCTE Regulations, 2007. As per provisions of the 2007 Regulations no institution shall be granted Recognition unless the Society or the institution is in possession of land on ownership basis. Leased land is permissible only if the lease is from Government or government agency..."

The above conclusion of the VT is not correct. The institution had applied for Recognition of B.Ed. course vide application dated 06.02.2006. Therefore, the NCTE Regulations, 2007 will not apply to it. The Regional Committee would have considered the case under NCTE Regulations, 2005, in which private lease deed was allowed.

As regards the other eight shortcomings, the explanation given by the institution is found to be satisfactory. Only remaining shortcoming is that the institution has not submitted a staff profile duly approved by the affiliating body, though the letter from the University constituting the Interview Committee is available on the file.

Hence, Show Cause Notice u/s 17 be issued for submission of approved staff profile."


Now therefore, this Show Cause Notice is issued u/s 17 of the NCTE Act, 1993. Your written representation should reach this office within 30 days from the date of this Notice. In case no representation is received within the stipulated time, it will be presumed that you have nothing to offer and in that event the WRC shall taken action for withdrawal of recognition u/s 17 of the NCTE Act, 1993.
