**Show Cause Notice under section 15(3)(b)**

WHEREAS, in terms of Section 15 of the NCTE Act, DIET Amreli, Plot/Khasara No. 1164, 1164/1, 1167, Street Number - Chittal, Village/ Post office - Amreli, Tehsil/Taluka - Amreli, District - Amreli- 365601, Gujarat, had submitted the application on 29.12.2012 to the Western Regional Committee, of the NCTE, for grant of recognition/permission for starting the B.Ed. course of two years duration with an annual intake of 50 students.

And whereas, the inspection of the institution was conducted on 08.02.2016.


And whereas, the visiting team report alongwith other documents, was placed before the WRC in its 243<sup>rd</sup> meeting held on 18<sup>th</sup> -20<sup>th</sup> February, 2016 and the Committee decided to issue letter of intent (LOI). LOI was issued on 24.02.2016.

And whereas, reply of letter of intent dated 26.02.2016, was placed before the WRC in its 245<sup>th</sup> meeting held on 1<sup>st</sup> -3<sup>rd</sup> March, 2016 and the Committee decided to issue Show Cause Notice on following grounds:-

"In response to LOI, the institution has submitted the list of faculty members. The list is not approved by the affiliating body. As per the NCTE Regulations, 2014, the list approved by the affiliating body can only be considered. Hence, Show Cause Notice be issued on the above grounds."

Now therefore, this Show Cause Notice is issued to the institution u/s 15 (3) (b) of the NCTE, Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation and the Western Regional Committee shall take the decision, as it deems fit and proper.
