WHEREAS, in terms of Section 14 of the NCTE Act, 1993, KISHORI SHIKSHA MAHAVIDHYALAYA, PLOT NO- 590/1, STREET- SATNARA ROAD, VILLAGE- KUKUDIJHAR, POST OFFICE- KUKUDIJHAR, TEHSIL- GOPAD BANAS, CITY- SIDHI, DISTRICT: SIDHI- 486661, MADHYA PRADESH had submitted the application on 28.06.2015 to the Western Regional Committee of the NCTE for grant of recognition for B.Ed. Course of 2 years duration with an intake of 01 units of 50 students.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 19.11.2015 has gave the negative recommendation.

AND WHEREAS, the SCN was issued to the institution on 12.02.2016 and the reply of SCN was received on 24.05.2016.

AND WHEREAS, the matter was placed before the WRC in its 257th Meeting held on August 2-4, 2016 and the Committee observed that "... Show Cause Notice dt. 12/02/2016 was issued, which returned undelivered. However, reply dt. 24/05/2016 has been received from Kishori Shiksha Mahavidyalaya informing that the address of the sponsoring Society was wrongly written by them earlier. Now they have informed the correct address of the Society.

The submitted documents were examined. It is seen that instead of a CLU, notice in Form-B has been submitted, according to which the land revenue has been revised. The notice is in the name of a private person and not the Kishori Shiksha Samiti. This is not acceptable.

Hence, Show Cause Notice be issued on this ground."

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 14(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 21 days from the date of issue of this notice. In the event of this office not receiving any representation within 21 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
