### **SHOW CAUSE NOTICE**

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, COLLEGE OF ADVANCE STUDIES, KHASRA NO- 2469/12 MIN-1, PLOT NO- 12, STREET NO- 01, VILLAGE- BIDNIA, POST OFFICE- DATIA, TEHSIL-DATIA, CITY- DATIA, DISTRICT: DATIA- 475661, MADHYA PRADESH had submitted the application on 29.06.2015 to the Western Regional Committee of the NCTE for grant of recognition for B.Ed. Course of 2 years duration.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has recommended the case.

AND WHEREAS, the WRC in its 241st meeting held on February 04-06, 2016 it was decide as under:-

"The WRC decided that the WRO should process these, constitute VTs where all documents are in order and issue Show Cause Notice to the rest. Action taken should be reported in the next meeting of the WRC."

### Hence, in view of the above, Show Cause Notice is issued on the following points:-

- 1. Photocopy of Land documents submitted but certified copy not submitted.
- 2. In Affidavit, Total land area is not clear.
- 3. University/Affiliating body NOC not submitted.
- 4. Photocopy of Building Plan submitted but notarized copy not submitted, Khasra no. not mentioned and address also not match with Online Application Form.
- 5. Notarized copy of Building Completion Certificate not submitted.
- 6. Notarized copy of Change of Land use Certificate not submitted.
- 7. Photocopy of Non Encumbrance Certificate (Search Report) submitted but notarized copy not submitted.
- 8. In Online Application Form & as per office record, institution has not applied for /nor conducting any other Teacher Education Course. Hence, institution is not fulfilling Clause 2(b) of NCTE Regulations, 2014.

AND WHEREAS, the Show Cause Notice was issued to the institution on 22.02.2016 and the reply received on 08.03.2016.

AND WHEREAS, the reply was placed before the WRC in its 248th WRC Meeting held on April 11-12, 2016, "the Committee also reviewed the status of the applications received for the academic session 2016-2017 and found that a number of applications where Show Cause Notices were issued and reply received are to be considered. In order to expedite the processing of such cases, the Committee decided that the RD, WRO should constitute VT in such cases where the institution has submitted reply/documents as per the requirements laid down in the NCTE Regulations, 2014 and in the Norms and Standards for that particular course. The case being up before the WRC on receipt of the VTR."

AND WHEREAS, the RD, WRO constituted the Visiting Team.

AND WHEREAS, the inspection letter was sent to the institution on 15.04.2016 and conducted of the institution on 26.04.2016 and VTR received in office on 29.04.2016.

**AND WHEREAS**, the VTR was placed before the WRC in its 251st WRC Meeting held on April 30- May 02, 201, and the Committee observed that "...The VT visited the institution on 26/04/2016. The VT report was perused and the CD viewed. The CD shows a building with infrastructural facilities which are not as per NCTE Norms. the VT remarked that the Library is only 46.46 sq. mtrs. and multipurpose hall is 167.28 sq. mtrs. the total number of books in the Library is only 1373 which is grossly less than requirement.

Hence, Show Cause Notice be issued on the above grounds."

AND WHEREAS, the Show Cause Notice was issued to the institution on **05.05.2016** and the reply received on **01.06.2016 & 23.06.2016**.

**AND WHEREAS**, the reply was placed before the WRC in its 263<sup>rd</sup> WRC Meeting held on November 25-27, 2016 and the Committee observed that "...Show Cause Notice was issued to the institution on 12/05/2016 on the ground that the areas of Library and multipurpose hall were small and there were only 1373 books in the Library.

The institution by way of reply sent bills for acquisition of books. However, the new CD submitted by the institution does not seem to show an increase in the area of Library and multipurpose hall.

The institution is required to send revised Building Plan and revised Building Completion Certificate signed by Govt. Engineer. The new Building Plan should show how the increase has been made.

Further, an examination of the documents show that the Building Plan, CLU, and Non-Encumbrance Certificate are not notarized.

The CD shows that all the rooms are earmarked with temporary paper signs.

Compliance in the above matters should be submitted within 30 days."

AND WHEREAS, the Compliance letter was issued to the institution on 29.11.2016 and the reply received on 21.12.2016.

**AND WHEREAS**, the reply was placed before the WRC in its  $267^{th}$  WRC Meeting held on January 23-25, 2017 and the Committee observed that "...Compliance letter was issued to the institution on 29/11/2016 and the institution replied on 21/12/2016.

The institution has still not submitted the premium receipt for the CLU.

However, LOI for 1 unit of the B.Ed. course will be issued by the WRO as soon as the institution submits the latest premium receipt for the CLU.

Hence, Clarification be obtained on the above ground.

Reply should be submitted within 30 days.

The Applicant be informed that only if the formalities necessary after issue of LOI are completed well before  $3^{rd}$  March, 2017, can the case be considered for the session 2017-2018."

AND WHEREAS, the Clarification letter was issued to the institution on 30.01.2017 and the reply received on 01.02.2017.

**AND WHEREAS**, a letter sent to the State Bank of India, Datia on **14.03.2017** regarding verification of the challan and the Letter of Intent under Clause 7(13) of the NCTE Regulations, 2014 was issued on **14.03.2017**.

**AND WHEREAS,** the reply received from the bank on **24.03.2017** and the institution has not submitted the reply of LOI, till date.

AND WHEREAS, the matter was placed before the WRC in its 275h WRC Meeting held on May 1-2, 2017 and the Committee observed that "...The WRO had sent copies of Challans supposedly to have been submitted to the bank as CLU receipt. There was 1 Challan which was supposed to have been credited in the head of account to 0029 and another identical Challan supposedly credited to the head of account 2900 both on 30/01/2017. The manager of the State Bank, Datia where these Challans were deposited, has written a letter confirming that the Challan has not been deposited in the Branch on 30/01/2017 in the name of Mukesh Yadav, Secretary, Manshee Jan Kalyan Samiti for Rs. 81,022 /-.

Hence, Show Cause Notice be issued to the institution as to why the Recognition should not be withdrawn on the above grounds under Section 17."

**NOW THEREFORE**, this Show Cause Notice is issued to the institution u/s 14(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within **30** days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
