**SHOW CAUSE NOTICE**

**WHEREAS**, in terms of Section 14 of the NCTE Act, 1993, **GYAN GANGA COLLEGE OF MANAGEMENT AND SCIENCE, PLOT NO-89/2, STREE NO-89/2, VILLAGE-CHAKRAIPURA, POST OFFICE-CHAKRAIPURA, TEHSIL-GWALIOR, CITY-GWALIOR, DISTRICT: GWALIOR-474010 MADHYA PRADESH** had submitted the application on **29.06.2015** to the Western Regional Committee of the NCTE for grant of recognition for B.Ed. Course of 2 years duration with an intake of 02 units of 50 students each.

**AND WHEREAS**, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 gave its recommendation.

**AND WHEREAS**, the SCN was issued to the institution on **20.02.2016** and the reply of SCN was not received."

**AND WHEREAS**, the matter was placed before the WRC in its 256<sup>th</sup> Meeting held on July 19-21, 2016 and the Committee observed that "...Show Cause Notice dt. 20/02/2016 was issued to the institution on the following grounds of non submission of:-

- Originally certified copy of land documents;
- Notarized copy of building plan, Building Completion Certificate and Non-Encumbrance Certificate; and
- NOC from the affiliating body.

It was seen from the file that the full address of the applicant as shown in the application was not written.

**Hence, Show Cause Notice be issued again...."**

**NOW THEREFORE**, this Show Cause Notice is issued to the institution u/s 14(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 21 days from the date of issue of this notice. In the event of this office not receiving any representation within 21 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
