SHOW CAUSE NOTICE

WHEREAS, recognition was granted to the institution namely, **DAU HANUMANT SINGH EDUCATION ACADEMY, PLOT NO-119, VILLAGE - GHURRAA, POST OFFICE - NEW COMMISHNARY, TEHSIL - JORA, DISTRICT - MORENA, MADHYA PRADESH** under section 14 of NCTE Act, 1993 for conducting D.El.Ed. course of two years duration with an annual intake of 50 students vide order dated 29.10.2010

AND WHEREAS, institution had applied for shifting of premises on 13.07.2016.

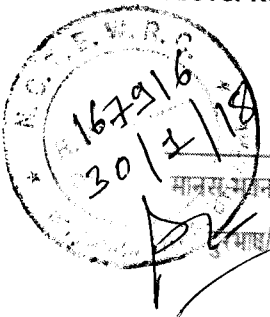
AND WHEREAS, the matter was placed before the WRC in its 265th meeting held on December 27-29, 2016 and the committee decided as follows "...This is a case of shifting. The institution wants to shift to plot. No. 22/2 and 22/5 in village Kheria Mirda, Gwalior. In the said plot, it is seen that two other teacher education institutions are being run. One is "Vyankatesh Education Academy" (APP9 - B.Ed. course) sanctioned vide order dt. 18/02/2014 and the another is "DHS Education Academy" (APP1700 - D.El.Ed. course) sanctioned vide order dt. 03/03/2016. Since there are already two teacher education institutions being run on the same plot, it is not possible to shift this teacher education institution "Dau Hanumant Singh Education Academy" (APP316) because the NCTE Regulations require that each teacher education institution should have independent land area of at least 2500 sq. mtrs. for running one course. Since, this land area is not available on khasra numbers 22/2 and 22/5. Shifting cannot be permitted. **Hence, Show Cause Notice be issued to the institution. Reply should be submitted within 30 days. An analysis of the 3 files show that the D.El.Ed. course (APP1700) and the B.Ed. course (APP9) are being run in two separate teacher education institutions on the same plot which is not permitted under the NCTE Regulations 2014. Hence, Show Cause Notice under Section 17 be issued to the institution DHS Education Academy (APP1700) as to why Recognition should not be withdrawn on the ground mentioned above.** Accordingly, Show Cause Notice was issued on 07.02.2017.

AND WHEREAS, the reply not received from the institution. The matter was placed before D.El.Ed. in its 285th meeting held on December 19-21, 2017 and the Committee decided that "...Shri Hanuman Singh Smriti Shiksha Prasara Evam Jankalyan Samiti runs the following:-

- DHS EDUCATION ACADEMY, GWALIOR, MADHYA PRADESH (APP1700) at Plot No.22/2, 22/5 in village Kheriya for D.El.Ed. course;
- SHRI VYANKATESH EDUCATION ACADEMY, GWALIOR, MADHYA PRADESH (APP9) at Plot No.22/2, 22/5 in village Kheriya for D.El.Ed. course; and
- DAU HANUMANT SINGH EDUCATION ACADEMY (APP316) at Khasra No.119, Village Girgaon for the D.El.Ed. course. The society wants to shift this course/institution to Khasra No.22/2, 22/5 in village Kheriya.

It is, therefore, clear that the intention of the management is to have three different institutions/courses in the same khasra number, which is not permitted under D.El.Ed. Regulations. Secondly, the land and built-up area are not sufficient for all the three courses mentioned above, if shifting is permitted. **Hence, shifting is not permitted.** For permission to continue in the existing premises, the institution should submit the videography of the existing building to the D.El.Ed. Thirdly, the latest staff profile in original approved by the competent authority should be submitted as also certificates of FDRs. The institution should submit certificates in original from the bank regarding payment of salary to the staff through the bank for the past six months. **On receipt of the above, a decision will be taken by the D.El.Ed. on continuation of the D.El.Ed. course in the existing campus. Hence, Show Cause Notice be issued to the institution as to why recognition should not be withdrawn on the grounds mentioned above. Reply should be submitted within one month."**
