**SHOW CAUSE NOTICE**

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, INSTITUTE OF PROFESSIONAL AND TECHNICAL EDUCATION, PLOT NO.: 230, STREET/ROAD: CHIRWAI NA, VILL.: PIPROLI, P.O.: PIPROLI, TEH./TAL.: GWALIOR, TOWN/CITY: GWALIOR, DIST.: GWALIOR - 474001, MADHYA PRADESH had submitted the application on 15.07.2015 to the Western Regional Committee of the NCTE for grant of recognition for B.A.B.Ed./B.Sc.B.Ed. Course of 4 years duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 11.08.2015 requesting to give their recommendation/comments.

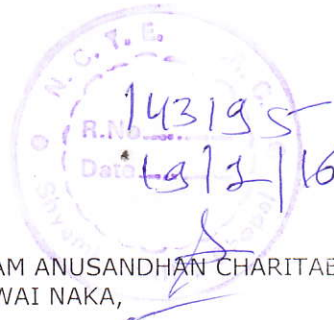
AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the matter was placed before the WRC in its 236<sup>th</sup> meeting held on December 15-16, 2015 and the Committee observed that "...This application was earlier rejected on the ground of delay in submission of hard copies of the application. Vide the order 27.11.2015 of Hon'ble High Court of Madhya Pradesh at Gwalior, it has been directed that since the application was submitted on time, the NCTE must take further action. The documents submitted by the applicant have been examined. It is seen that the applicant has not submitted the following:-

- (i) Certificate of registration of Society, bye-laws, memorandum of association not submitted;
- (ii) Notarized copy of the Building completion certificate in the proper format not submitted; and
- (iii) Further the applicant has to clarify as to which course he has applied for - B.A. B.Ed. Or B.Sc. B.Ed.

Hence, Show Cause Notice be issued on the above grounds."

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 14(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
