SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, **YOUTH FOR NATION SOCIAL WELFARE EDUCATION SOCIETY, PLOT NO.7 & 8, SETH PHOOLCHAND NAGAR, VILLAGE - RAISEN, POST OFFICE/TOWN/CITY - MANDIDEEP, TEHSIL/TALUKA - GOHARGANJ, DISTRICT - RAISEN, PIN CODE - 462046, MADHYA PRADESH** had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition in D.El.Ed. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 13.08.2015, 28.10.2015, and 09.12.2015 requesting to give their recommendation/ comments.

AND WHEREAS, Rajya Shiksha Kendra, Bhopal, Madhya Pradesh vide letter dated 04.01.2016 has given their recommendation.

AND WHEREAS, the matter was placed in 240th WRC meeting held on January 20-22, 2016 and the Committee decided that Show Cause Notice be issued to the institution. Accordingly, Show Cause Notice was issued on 27.01.2016.

AND WHEREAS, reply not received from the institution. The matter was placed in the 247th WRC meeting held on April 4-6, 2016 and the Committee observed that "...Show Cause Notice was issued to the institution on 27/01/2016 on the ground that the institution is not a composite one which is not permitted as per section 2(b) of the NCTE Regulations, 2014. The institution has not replied till date. Hence, Recognition is refused. FDRs if any, be returned." Accordingly, Refusal order was issued on 20.04.2016.

AND WHEREAS, the institution preferred an appeal before the Council (NCTE) u/s 18 of NCTE Act, 1993, against the Refusal order dated 20.04.2016 and the Council vide order dated 04.08.2016 remanded the case to WRC with a direction to consider the reply to the show cause notice and take further action as per the NCTE Regulation.

AND WHEREAS, the aforesaid appeal order was placed before WRC in its 259th meeting held on September 21-23, 2016 and the Committee decided that "...This is a case of Appeal. The Appellate Authority vide order dt. 04/08/2016 has remanded the case to WRC to take further action as per NCTE Regulations. The institution has submitted the reply to the refusal order issued on 20/04/2016. The institution has sent a copy of the letter received from Barkatullah University, Bhopal conveying NOC to run first year courses in History, Sociology, and Political Sciences. The WRO should examine all the documents submitted and put up the case in the next meeting."

AND WHEREAS, the matter was again placed before WRC in its 265th meeting held on December 27-29, 2016 and the Committee decided that "...An examination of the file shows that the institution has submitted all the required documents except for notarized copy of the Building Plan and Building Completion Certificate. Hence, VT be constituted and the VT should obtain notarized copies of the Building Plan and Building Completion Certificate from the management."

AND WHEREAS, the inspection of the institution was conducted on 07-08.01.2017.

AND WHEREAS the original file, visiting team and other relevant documents were considered by WRC in its 268th Meeting of WRC held on February 09-11, 2017 and the Committee decided that "...The VT visited the institution on 07/01/2017 and 08/01/2017. The VTR was perused and the CD viewed. The CD shows a good building with good infrastructural and instructional facilities. The VT has recommended the case. However, before LOI can be issued, the institution needs to submit a copy of the affiliation letter from the University. **Hence, Show Cause Notice be issued on the above ground. Reply should be submitted within 30 days.**"
