

### SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, MAA CHANDRIKA COLLEGE DEVPUR TIGAILA, PLOT NO.: 117/1, 118, STREET/ROAD: DEVPUR TIGAILA, VILL.: BAMHORIYA, P.O.: DEVPUR, TEH./TAL.: CHHATARPUR, TOWN/CITY: CHHATARPUR, DIST.: CHHATARPUR - 471001 (MP) had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition for B.A.B.Ed./B.Sc.B.Ed. Course of 4 years duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 07.08.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the matter was placed before the WRC in its 237<sup>th</sup> meeting held on December 21-22, 2015 and the Committee observed that "...The applicant has applied for an integrated course, it is not clear whether it is B.A. B.Ed. or B.Sc. B.Ed. The Society be asked to clarify whether it is applying for B.Sc. B.Ed. Or for B.A. B.Ed.

The documents submitted by the applicant were seen and it is noticed that:-

- (i) While the land documents, building plan and CLU are as per the requirement, the building completion certificate and non-encumbrance certificate have not been submitted. But the main problem in this case is that the Society is not recognized for any other course as per the information submitted to NCTE. The application is only for one course. Hence, even if this course is recognized, the applicant will not meet the requirement of clause 2(b) of NCTE Regulations, 2014;
- (ii) FDRs not submitted as per NCTE Regulations, 2014; and
- (iii) The Department of Higher Education, Govt. of M.P. has not recommended the case on the ground that it is not a composite institution.

**Hence, Show Cause Notice be issued on the above grounds."**

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 14(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
