**SHOW CAUSE NOTICE**

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, **K.R. ACADEMY, PLOT NO- 216/4, VILLAGE- RAJODA, POST OFFICE- DEWAS, TEHSIL- DEWAS, CITY- DEWAS, DISTRICT: DEWAS- 455001, MADHYA PRADESH** had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition/permission for B.Ed. integrated course of 2 years duration.

**AND WHEREAS**, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 13.08.2015 requesting to give their recommendation/comments.

**AND WHEREAS**, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

**AND WHEREAS**, the WRC in its 241<sup>st</sup> meeting held on February 4-6, 2016 decide that WRO should process the case and constitute VT/issued Show Cause Notice, as the case may be.

**AND WHEREAS**, the application was scrutinize and following deficiencies/shortcoming were observed:-

1. Serial No. 5 not filled in the Affidavit.
2. Address of the institution not mentioned in NOC of the University/Affiliating body.
3. Photocopy of Building Plan submitted but blue-print/notarized copy not submitted and Built-up area is less as per NCTE norms.
4. Notarized copy of Building Completion Certificate not submitted.
5. Notarized copy of CLU not submitted.
6. Notarized copy of Non-Encumbrance Certificate not submitted.
7. FDRs not submitted as per NCTE norms.
8. In Online Application Form & as per office record, institution has not applied for /nor conducting any other Teacher Education Course. Hence, institution is not fulfilling Clause 2(b) of NCTE Regulations, 2014.

**AND WHEREAS**, the Show Cause Notice was issued to the institution on **16.02.2016** on above ground and reply received on **15.03.2016**.

**AND WHEREAS**, the matter was placed before the WRC in its 248<sup>th</sup> Meeting held on April 11-12, 2016, the committee observed that:- The Committee also reviewed the status of the applications received for the academic session 2016-2017 and found that a number of applications where Show Cause Notices were issued and reply received are to be considered. In order to expedite the processing of such cases, the Committee decided that the RD, WRO should constitute VT in such cases where the institution has submitted reply/documents as per the requirements laid down in the NCTE Regulations, 2014 and in the Norms and Standards for that particular course. The case be put up before the WRC on receipt of the VTR.

**AND WHEREAS**, the RD WRO constituted the visiting team.

**AND WHEREAS**, the inspection letter issued to the institution on **02.05.2016** and the inspection conducted of the institution on **06.05.2016**.

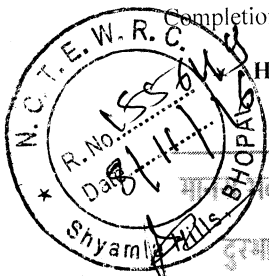
**AND WHEREAS**, the matter was placed before the WRC in its 260<sup>th</sup> Meeting held on October 13-15, 2016, the committee observed that:-

"....The VT visited the institution on 06/05/2016. The VTR was perused and the CD viewed.

While the CD shows a four storied large building, the building plan is for ground + two floors and Building Completion Certificate is for ground and first floor. The management should reconcile these differences.

Hence, Show Cause Notice be issued on the above grounds."
