SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, **ISHWARCHAND VIDYASAGAR MAHAVIDYALAYA, PLOT/ KHASARA NO- 426/1, 426/2, 434/2, 438/5, STREET- CHILLA, VILLAGE- PATHRAUDA JAWA, TEHSIL- JAWA, CITY- REWA, DISTRICT: REWA- 486223, MADHYA PRADESH** had submitted the application on **30.06.2015** to the Western Regional Committee of the NCTE for grant of recognition for B.Ed. Course of 2 years duration.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 08.09.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the WRC in its 241st meeting held on February 4-6, 2016 decide that WRO should process the case and constitute VT/issued Show Cause Notice, as the case may be.

AND WHEREAS, the application was scrutinize and following deficiencies/shortcoming were observed:-

1. Certified copy of registered land documents issued by the competent authority as required under provision of section 8(4)(i) of NCTE, Regulations, 2014 not submitted.
2. Blue Print/ Notarized copy of Building Plan issued by competent authority not submitted.
3. A notarized copy of Change of land use (CLU) certificate not Submitted.
4. FDRs as per NCTE Regulations, 2014 not submitted.

AND WHEREAS, the Show Cause Notice was issued to the institution on **17.02.2016** and reply received on **16.03.2016**.

AND WHEREAS, the matter was placed before the WRC in its 254th Meeting held on June 7-9, 2016 and the Committee observed that "...Show Cause Notice was issued on 17/02/2016 and the reply was received on 16/03/2016. Regarding the land documents, it is seen that the institution has submitted land documents of Khasra Nos. 426/1, 426/2 and 438/2, whereas in the application, Khasra No. mentioned are 434/2 and 438/5 for which land documents have not been submitted. CLU has not been submitted.

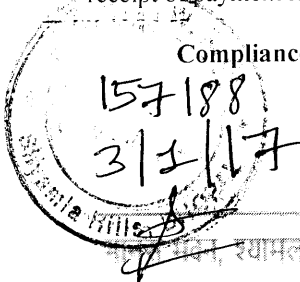
Hence, Clarification be obtained on the above grounds."

AND WHEREAS, the Clarification letter issued to the institution on **13.06.2016** and the inspection conducted of the institution on **18.07.2016 & 02.09.2016**.

AND WHEREAS, the matter was placed before the WRC in its 262nd Meeting held on November 10-11, 2016 and the Committee observed that "...The Clarification letter was sent to the institution on 13.06.2016. The institute has submitted certified copy of land documents. However regarding CLU it has submitted "प्रपत्र बी" but receipt of payment has not been submitted.

Compliance be submitted within 30 days."


AND WHEREAS, the letter issued to the institution on **16.11.2016** and the inspection conducted of the institution on **30.11.2016**.

AND WHEREAS, the matter was placed before the WRC in its 264th Meeting held on December 14-15, 2016 and the Committee observed that "...Compliance letter was issued on 16/11/2016 regarding CLU. An examination of the documents shows that the institution has submitted a number of land documents. However, as per Non-Encumbrance Certificate, the building is situated at Khasra No. 434/2.

The institution is required to send originally certified copy of land document at khasra no. 434/2, notarized copy of Building Plan approved by the competent authority at 434/2 and the Building Completion Certificate.

Hence, Show Cause Notice be issued on the above ground."

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 14 (3) (b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 21 days from the date of issue of this notice. In the event of this office not receiving any representation within 21 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
