SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, **SIDDHI VINAYAK COLLEGE, PLOT NO- 356, POST OFFICE- NARWAR, VILLAGE- NARAYANPUR, POST OFFICE- NARWAR, TEHSIL- NARWAR, CITY- NARWAR, DISTRICT: SHIVPURI- 473880, MADHYA PRADESH** had submitted the application on **30.06.2015** to the Western Regional Committee of the NCTE for grant of recognition for B.Ed. Course of 2 years duration.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the negative recommendation.

AND WHEREAS, the matter was placed before the WRC in its 232nd Meeting held on September 16-17, 2015 and the Committee observed that "...The institution has submitted processing fee after the date of the online application.

Hence, the application is summarily rejected."

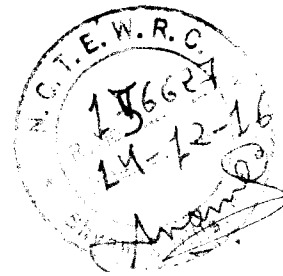
AND WHEREAS, the Rejection Letter was issued on **15.10.2015**.

AND WHEREAS, Court Order dated 09.09.2016 Writ Petition No. 2821/2016 filed by institution at the Hon'ble High Court of Madhya Pradesh, Bench at Gwalior.

AND WHEREAS, the matter was placed before the WRC in its 263rd Meeting held on November 25-27, 2016 and the Committee observed that "...The application was rejected on the ground that the institution had submitted the processing fee after the last date for submission of the online application. The institution filed a petition in the Hon'ble High Court of M.P. Bench at Gwalior.

The Court has observed that the WRC had not provided any notice nor any opportunity of hearing before the issue of the order. The Hon'ble Court also quashed the WRC order dt. 15/10/2015.

Hence, Show Cause Notice be issued to the institution on the ground that the institution submitted the processing fee after the last date of the online application. The reply be submitted within 30 days."
