Show Cause Notice under section 17 (1)

Whereas, the recognition was granted to the institution namely, **Shyam Narayan Education Trust, Param Pujya Swami Karpatji College of Education, Manorama Ngar Dholali, Thane (W) Maharashtra** for conducting D.Ed.(Marathi) Co-ed Course of 2 years with annual intake of 50 students from the academic session 2007-2008 vide order no WRC/NCTE/2006-2007 dt. 04.05.2007.

And whereas, the institution has submitted an application dt 15.04.2013 for shifting of premises from Manorma Nagar , Dhokli Thane, Maharashtra to Narayangaon Post Malegaon Teh Shapur Dist Thane, Maharashtra.

And whereas, the institution was informed vide letter dt 22.03.2016 to submit the following documents for processing the application for shifting the institution are as follows:-

1. Processing fee as per NCTE regulations 2014
2. Copy of application in triplicate.
3. Certified copy of registered land Documents of new Location issued by Sub- Registrar.
4. Approved Building Plan.
5. BCC issued by competent authority.
6. Land use certificate issued by SDM for use of land educational purpose.

And whereas, the matter was placed before the WRC in its 286th meeting held on 16th-17th January, 2018 and the Committee decided as follows:-


"...The case file was seen. The institution has been informed vide letter dated 22.03.2016 from WRO to submit various documents which are required for shifting. The institution has not replied till date.

Hence, Show Cause Notice be issued to the institution on the above points as to why the shifting of premises should not be refused and recognition be withdrawn...

Notice is issued u/s 17 (1) of NCTE Act, 1993 with the direction to submit your written representation with in a period of 30 days from the date of dispatch of this notice.

However, if your written representation is not received within 30 days, it will be presumed that you have nothing to say, and in that event the WRC shall be free to take its decision as per the Regulations of NCTE.
