**Show Cause Notice** 

Whereas, in term of Section 14 of the NCTE Act 1993, Shri Shakuntal Secondary Teachers Training College, The New Sharda Education Trust Sonal Char Rasta, Gurukul Road, Memnagar Ahmedabad 52, Gujarat was granted recognition for conducting B.Ed. course of one year duration vide order No. WRC/2-32/323226/74/2005/4973 dated 27.06.2005 with an intake of 100 students.

And, whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 01.12.2014

And, whereas, LETTER REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 14.01.2015 for submission of affidavit in the prescribed format, failing which the revised order of recognition will not be issued and the recognition granted earlier will become invalid.

And, whereas, the institution did not submit Affidavit for compliance of NCTE Regulations, 2014.

And, whereas, Revised Recognition order was also not issued to the institution.

And, whereas, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 regarding non submission of affidavit by the institutions. The Committee decided that "...Show Cause Notices be issued to the institutions.."

Now, therefore, this Show Cause Notice is issued to the institution u/s 17 of NCTE, Act, 1993 giving an opportunity for making written representation within a period of 21 days from the date of issue of this notice. In the event of this office not receiving any representation within 21 days of the issue of this notice, it will be presumed that you do not wish to make any representation and the Western Regional Committee shall take the decision, as it deems fit and proper.
