SHOW CAUSE NOTICE

WHEREAS, recognition was granted to the institution namely, SHIVA COLLEGE OF EDUCATION, RUN BY A.S KHARB MEMORIAL TRUST, VILL-GARIPIPLIA, NEAR M.D.I.T.M, INDORE, MADHYA PRADESH under section 14/15(3)(a) of NCTE Act, 1993 for conducting D.El.Ed. course of two years duration with an annual intake of 50 students vide order dated 30.09.2008.

AND WHEREAS, the institution applied under section 8 (9) of NCTE Regulations 2014, for change of premises from SHIVA COLLEGE OF EDUCATION, RUN BY A.S KHARB MEMORIAL TRUST, VILL-GARIPIPLIA, NEAR M.D.I.T.M, INDORE, MADHYA PRADESH to **SHIVA COLLEGE OF EDUCATION, KHASRA NO. - 43/1/2/3, 43/2/1 & 43/2/2, VILLAGE/TOWN/CITY - VILL DUDHIYA, DISTRICT - INDORE, MADHYA PRADESH** on 17.05.2012

AND WHEREAS, the matter was placed before the WRC in its 282nd meeting held on October 24-26, 2017 and the Committee decided that "...This is a case of shifting. On examination of the file shows that the institution needs to submit the following:-

- FDR for Rs.12.00 lakhs;
- Non-encumbrance certificate issued by Sub-Registrar; and
- The latest list of faculty duly approved by the competent authority.

Hence, Show Cause Notice be issued on the above points. Reply should be submitted within one month."

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 17 of the NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
