**Show Cause Notice**

Whereas, R K Vidya Prasar Mandal, Plot No. - 503 Ramkumar, Street No. - Valliper Road, Vill. - Mansion Above Dr. Tike, P.O./City - Kalyan W, Tehsil - Hospital Kalyan W, District - Thane - 421301, Maharashtra had submitted the application on 30.12.2012 to the Western Regional Committee of the NCTE for grant of recognition to Dr. DSP College of Education and Research, Plot No. - 25, Street No. - Kachore, Village - Kachore Gaon Road, P.O. - katemanawali Kalyan, Tehsil/City - Kalyan, Dist. - Thane - 421306, Maharashtra for starting the B.Ed. course with an annual intake of 100 students.

And, whereas, the application of the institution was processed and deficiencies communicated to the institution vide letter dated 11.03.2013, The institution did not submit reply of Deficiency Letter.

And, whereas, the matter was placed before WRC in its 186<sup>th</sup> meeting held on 12 - 13 July, 2013 and the Committee decided to issue show cause notice to the institution. Accordingly, show cause notice was issued on 05.08.2013. and institution submitted reply of SCN on 03.09.2013.

And, whereas, the matter was placed before WRC in its 190<sup>th</sup> meeting held on 18 - 20 September, 2013 and the Committee decided that VT be constituted. Accordingly, inspection was conducted on 26.10.2013

And, whereas, the matter was placed before WRC in its 195<sup>th</sup> meeting held on 4 - 6 December, 2013 and the Committee decided to issue show cause notice to the institution. Accordingly, show cause notice was issued on 14.12.2013 and institution submitted reply of SCN.

And, whereas, the matter was placed before WRC in its 220<sup>th</sup> meeting held on March 23-24, 2015 and the Committee decided to issue letter of intent to the institution. Accordingly, letter of intent was issued on 09.04.2015 and institution did not submit reply of letter of intent.

And, whereas, the matter was placed before WRC in its 240<sup>th</sup> meeting held on 20-22, January, 2016, and the Committee decided as follows:-

"...LOI dt. 09/04/2015 was issued. So far, no reply has been received from the applicant. Hence, Show Cause Notice be issued on this ground."

Now, therefore, in exercise of the powers vested in the Western Regional Committee under Section 14(3)(b) of NCTE, Act. 1993, an opportunity is hereby given to the said institution for making written representation within 30 days of the issue of this notice before refusing recognition for B.Ed course.
