### SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, **SADGURU SHIKSHAN SAMITI, PLOT NO. BM-194, STREET/ROAD – NEHRU MAGAR, VILLAGE – BHOPAL, POST OFFICE – KAMLA NAGAR BHOPAL, TEHSIL/TALUKA – HUZUR, TOWN/CITY/DISTRICT – BHOPAL, PIN CODE – 462003, MADHYA PRADESH** had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition for D.El.Ed. Course of 2 years duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 30.10.2015, 17.12.2015, and 08.01.2016 requesting to give their recommendation/ comments.

AND WHEREAS, Rajya Shiksha Kendra, Bhopal, Madhya Pradesh vide letter dated 04.01.2016 has given their recommendation.

AND WHEREAS, the matter was placed before the WRC in its 240<sup>th</sup> WRC meeting held on January 20-22 2016 and the Committee observed that "...The course applied for is D.El.Ed. No other course has been applied for, nor is any other course being conducted by this applicant. Hence, Section 2(b) of the NCTE Regulations, 2014 is attracted.

Apart from the above, the following lacuna are also seen :-

- i) The sale deed mentions the name of an individual;
- ii) Notarized CLU has not been submitted;
- iii) Notarized copy of the Building Plan submitted, but total built up area not mentioned;
- iv) Notarized copy of Building Completion Certificate submitted, but Khasra nos not mentioned. Built up area 12,180 Sq. ft. is not sufficient;
- v) Notarized copy of Non-Encumbrance Certificate not submitted;
- vi) NOC from the affiliating body not submitted; and
- vii) FDRs have also not been submitted.

Hence, issue Show Cause Notice on the above grounds."

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 14/15(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
