SHOW CAUSE NOTICE

WHEREAS, recognition was granted to the institution, namely, **SHREE INSTITUTE OF TEACHERS EDUCATION, C/O SHREE INSTITUTE OF SCIENCE AND TECHNOLOGY, GONDERMAN, NEW JAIL ROAD, NEAR RGPV, BHOPAL 462036 MADHYA PRADESH** under section 14 of NCTE Act, 1993 for conducting **B.ED.** course for the academic session 2004-2005 vide orderS dated **10.06.2004 & 14.12.2004.**

AND WHEREAS, one Shri Pawan Dubey had filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court had directed to inspect all B.Ed. institutions in the State of Madhya Pradesh. Since, the institutions are existing institutions, the inspection was to be conducted by NCTE Hqrs. u/s 13 of the NCTE Act.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on **17.01.2015** and the reply was received on **05.02.2015.**

AND WHEREAS, Revised Recognition order was issued to the institution on **31.05.2015.**

AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on **20.11.2014.**

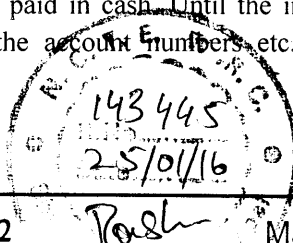
AND WHEREAS, the Deficiency Letter was issued by the NCTE HQRs. to the institution on **28.04.2015** and the reply of Deficiency Letter was received in NCTE HQRs. on **29.05.2015.**

AND WHEREAS, the VTR/letter was received from NCTE Hqrs. in WRO on **12.11.2015.**

AND WHEREAS, the matter was placed in **237th Meeting held on December 21-22, 2015** of WRC and the Committee decided that "...The institution was inspected by a visiting team constituted by NCTE hqrs. The visiting team has noted the physical infrastructure which as per the norms is adequate. On the points included in the letter issued by the NCTE hqrs. to the institution and the reply received from the institution, it is observed that:-

- (i) The institution has still not enclosed the renewed FDRs for Endowment and Reserve fund, only photocopies have been submitted;
- (ii) As regards the attendance, the institution had explained that the students had gone for practice teaching which had been scheduled from 15.10.2014 to 15.12.2014. Hence, on the date of inspection, less number of students were seen;
- (iii) The institution has already appointed Art, Physical Education and ICT teachers;
- (iv) As regards the salary of the staff is concerned, the explanation of the institution is not satisfactory, sometimes only the salary is paid in cash. Until the institution submits the photocopies of attested bank statements alongwith the account numbers, etc. the explanation presently given cannot be accepted;

- (v) The other point of the inspection team regarding augmentation of instructional facilities in the labs and in library, the institution has enclosed the list of books in the library and photographs of psychology and common room. The response of the institution on these points is satisfactory.
- (vi) The institution has applied for NAAC accreditation and updates its website.

Hence, Show Cause Notice be issued on the point No.1 & 4.”

Now therefore, this Show Cause Notice is issued u/s 17 of the NCTE Act, 1993. Your written representation should reach this office within 30 days from the date of this Notice. In case no representation is received within the stipulated time, it will be presumed that you have nothing to offer and in that event the WRC shall taken action for withdrawal of recognition u/s 17 of the NCTE Act, 1993.


