SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14 of the NCTE Act, SARDAR PATEL COLLEGE OF EDUCATION, PLOT/KHASRA NO: 36. 60/10 59 65/8. 61/8. 13 68/2, STREET: GONDIA ROAD, VILLAGE: KHURSODI. POST OFFICE: KHURSODI, TEHSIL: BALAGHAT, CITY: BALAGHAT, DISTRICT: BALAGHAT- 481001, MADHYA PRADESH had submitted the application on 26.05.2015 to the Western Regional Committee of the NCTE for grant of recognition for B.Ed. Course of 2 years duration.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the matter was placed before the WRC in its 243rd Meeting held on February 18-20, 2016 and the Committee observed that "...Show Cause Notice dt. 02/12/2015 was issued. The applicant has replied vide letter dt. 14/12/2015. Regarding the land document, it has been stated that the certified land document was submitted earlier.

The originally certified copy of land document is available in this file (APP2635). This has been verified. It is seen that the diverted area 2024 sq. mtrs. is less than the requirement of 3000 sq. mtrs. for the two applied for courses. Therefore, the applicant should get the remaining required area diverted and submit documentary proof thereof to the RD/WRO.

The applicant should also be informed that since he has applied for B.Ed. on the same land, the land area, built up area and diverted area are sufficient only for one unit of integrated course, and one unit of B.Ed. - refer Appendix-13 and Appendix-4 of the NCTE Regulations, 2014.

Hence, VT be constituted for one unit of B.Ed. course."

AND WHEREAS, the inspection letter issued to the institution on 23.02.2016 and the inspection conducted of the institution on 29.02.2016.

AND WHEREAS, the matter was placed before the WRC in its 248th Meeting held on April 11-12, 2016 and the Committee observed that "...The cases APP 2620 and APP2635 were taken together. The report of the VT was perused and the CD was viewed. On perusal of the CD it has been found that the institution has the required infrastructural and instructional facilities. The VT has recommended the case.

However, on perusal of the records, it has been found that the institution has submitted CLU for 2024 sq. mtrs. of land whereas, the diverted land should not be less than 3000 sq. mtrs. The institution in its affidavit has also mentioned that it has land with diverted area 2024 sq. mtrs.

Hence, Show Cause Notice be issued on the above grounds."

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 14(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
