SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14 of the NCTE Act, 1993 COLLEGE OF ADVANCE STUDIES, KHASRA NO- 2469/12 MIN-1, PLOT NO- 12, STREET NO- 01, VILLAGE- BIDNIA, POST OFFICE- DATIA, TEHSIL- DATIA, CITY- DATIA, DISTRICT: DATIA- 475661, MADHYA PRADESH had submitted the application on 29.06.2015 to the Western Regional Committee of the NCTE for grant of recognition for B.Ed. Course of 2 years duration.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, SCN has been sent to the institution on 22.02.2016 at office level as per decision of WRC taken in 241st Meeting and the reply was received on 08.03.2016.

AND WHEREAS, the VT has been constituted at office level as per decision of WRC taken in 248th Meeting.

AND WHEREAS, the inspection letter issued to the institution on 15.04.2016 and the inspection conducted of the institution on 26.04.2016.

AND WHEREAS, the matter was placed before the WRC in its 251st Meeting held on April 30- May 2, 2016 and the Committee observed that "...The VT visited the institution on 26/04/2016. The VT report was perused and the CD viewed. The CD shows a building with infrastructural facilities which are not as per NCTE Norms. the VT remarked that the Library is only 46.46 sq. mtrs. and multipurpose hall is 167.28 sq. mtrs. the total number of books in the Library is only 1373 which is grossly less than requirement.

Hence, Show Cause Notice be issued on the above grounds."

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 14(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
