WHEREAS, in terms of Section 15 of the NCTE Act, 1993, R D EDUCATION SOCIETY, STREET/ROAD - MAHOBA ROAD, VILLAGE - VISHVANATHA COLONY, POST OFFICE/TEHSIL/ TALUKA/TOWN/CITY/DISTRICT - CHHATARPUR, PIN CODE - 471001, MADHYA PRADESH had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition for D.El.Ed. Course of 2 years duration with an annual intake of 50 students.

AND WHEREAS, as per public notice dated 27.02.2015 applications were not invited for D.El.Ed. course from Madhya Pradesh except from 20 districts which were listed in the notification. The application submitted by R D EDUCATION SOCIETY, STREET/ROAD - MAHOBA ROAD, VILLAGE VISHVANATHA COLONY, POST OFFICE / TEHSIL/TALUKA/TOWN/CITY/ DISTRICT-CHHATARPUR, PIN CODE - 471001, MADHYA PRADESH was from the banned districts.

AND WHEREAS, the Hon'ble High Court of Madhya Pradesh, at Jabalpur in the context of Ambition College of Education, had passed an order dated 28.01.2016 in which it has been directed that, '...In our opinion, the condition specified in the impugned notification dated 27.02.2015 (Annexure-P/3) to exclude 20 districts of State of Madhya Pradesh from consideration, deserves to be quashed and set aside in terms of this order. In other words, all applications received before the cut off date including of the respondent No.1 from concerned twenty districts of State of Madhya Pradesh ought to be treated as valid and eligible to participate in the consideration process. Indisputably, the petitioner had submitted such application in response to the notification on 30.06.2015, which is within the extended cut off date(i.e. 30.06.2015). In that, the fact that the petitioner had submitted application on 30.06.2015 has not been disputed. For that reason, respondent No.1 and other statutory Authorities will be obliged to decide the application preferred by the petitioner and take a final decision thereon expeditiously and not later than 3rd March, 2016. If any other application has been received from the districts which were otherwise excluded in terms of the impugned notification, within specified time, even those applications be processed by the respondent No.1 and other statutory Authorities in accordance with law before 3rd March, 2016 and decision thereon be communicated to the concerned applicants. If the decision is adverse to the concerned applicants, they will be free to challenge the same on grounds as may be permissible in law...'.

In view of the above directions of the Hon'ble High Court, WRC in its 241st meeting held on February 4-6, 2016 directed the RD / WRO to take action on each such application received.

AND WHEREAS, the institution filed W.P. No.(C) 6081/2015 & C.M. No.11056/2015 before the Hon'ble High Court of Delhi at New Delhi and the Hon'ble High Court had passed an order dated 02.02.2016 in which it has been directed that, '...The application filed by the petitioners will be decided by the respondents and a final decision will be taken thereon expeditiously, but not later than 3rd March 2016. If a decision is adverse to the petitioners, they will be free to file appropriate proceedings in accordance with law."

NCTE hars has filed SLP in the Hon'ble Supreme Court against the order of the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble Supreme Court has directed to process the case but no order shall be passed thereon. The matter is next listed for hearing on 26.04.2016.

AND WHEREAS, the matter was placed in the 246th Meeting of WRC held on March 16-18, 2016 and the Committee decided that Show Cause Notice be issued to the institution. Accordingly, Show Cause Notice was issued on 21.03.2016. Reply submitted by the institution on 01.04.2016.

AND WHEREAS, WRC in its 248th meeting held on April 11-12, 2016 decided that "...The Committee also reviewed the status of the applications received for the academic session 2016-2017 and found that a number of applications where Show Cause Notices were issued and reply received are to be considered. In order to expedite the processing of such cases, the Committee decided that the RD, WRO should constitute VT in such cases where the institution has submitted reply/documents as per the requirements laid down in the NCTE Regulations, 2014 and in the Norms and Standards for that particular course. The case be put up before the WRC on receipt of the VTR."

AND WHEREAS, the inspection of the institution was conducted on 17.04.2016.

AND WHEREAS, the original file, visiting team report and other relevant documents were considered by WRC in its 249th meeting held on April 21-23, 2016 and the Committee observed that "...The VT visited the institution on 17/04/2016. The VT report was perused and the CD viewed. The CD shows a building with adequate infrastructural and instructional facilities. However, an examination of the file shows that the total land area is only .308 hectares which is insufficient to run 2 units of existing B.Ed. course and the proposed one unit of the D.El.Ed. course. The requirement is 3500 sq. mtrs. Hence, Show Cause Notice be issued on this ground."

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 15(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
