SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, **MAA JWALA DEVI BAL VIKASH EVAM SHIKSHA PRASAR SAMITI, PLOT NO.326,357, VILLAGE/POST OFFICE/TEHSIL/TALUKA - PORSIA, TOWN/CITY/DISTRICT - MORENA, PIN CODE - 476115, MADHYA PRADESH** had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition for D.El.Ed. Course of 2 years duration with an annual intake of 50 students.

AND WHEREAS, the matter was placed before WRC in its 234th meeting held on November 3-5, 2015 and the Committee decided that "...As per public notice dated 27.02.2015 applications were not invited for D.El.Ed. course from Madhya Pradesh except from 20 districts which were listed in the notification. The WRO presented a list of 30 applications submitted for the D.El.Ed. course in agenda no 13 which are from the districts from where applications were not to be accepted. The WRC, therefore, decided to return the applications to these institutions alongwith processing fee. Copies of the letters be sent to NCTE Hqrs for refund of fees." Accordingly, application was returned on 12.11.2015.

AND WHEREAS, the institution filed W.P. No.860/2016 before the Hon'ble High Court of Madhya Pradesh, Bench at Gwalior and the Hon'ble High Court had passed an order dated 04.02.2016.

AND WHEREAS, the institution resubmitted the application to WRO on 11.02.2016 for reconsideration.

AND WHEREAS, the matter was placed before WRC in its 247th meeting held on April 4-6, 2016 and the Committee decided that "...This case is seen in conjunction with another application for the B.Ed. course (APP3364). An examination of both the files shows that the institution has submitted all the documents except NOC from the affiliating body. It is further noticed that CLU is only for 11250 sq. ft. which is less than the requirement. Building Plan is not approved by the competent authority and is not readable. A blueprint should be submitted. Hence, Show Cause Notice be issued on the above grounds. Letter to the State Govt. for seeking its recommendation be sent under clause 7(4)."

Besides this, you are also hereby directed to re-submit the processing fee of Rs.1,50,000/- DD No.006061 dated 30.05.2015 for Rs.1,50,000/-. The DD submitted by you is sent herewith for revalidation.

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 14(3)(b) of NCTE Act, 1993 on the above points giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
