**SHOW CAUSE NOTICE**

WHEREAS, in terms of Section 15 of the NCTE Act, 1993, VINDHYANCHAL SHIKSHA SAMITI, PLOT NO -166, STREET - GOVINDGARH ROAD, VILLEGE - GANGAPUR, POST OFFICE - DIGHIYA, TEHSIL - HUZUR,CITY/DIST - REWA, PIN CODE 486001 MADHYA PRADESH had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition for D.El.Ed. Course of 2 years duration with an annual intake of 50 students.

AND WHEREAS, the matter was placed before WRC in its 234<sup>th</sup> meeting held on November 3-5, 2015 and the Committee decided that "...As per public notice dated 27.02.2015 applications were not invited for D.El.Ed. course from Madhya Pradesh except from 20 districts which were listed in the notification. The WRO presented a list of 30 applications submitted for the D.El.Ed. course in agenda no 13 which are from the districts from where applications were not to be accepted. The WRC, therefore, decided to return the applications to these institutions alongwith processing fee. Copies of the letters be sent to NCTE Hqrs for refund of fees." Accordingly, application was returned on 09.11.2015.

AND WHEREAS, the Hon'ble High Court of Madhya Pradesh, at Jabalpur in the context of Ambition College of Education, had passed an order dated 28.01.2016 in which it has been directed that, "...In our opinion, the condition specified in the impugned notification dated 27.02.2015 (Annexure-P/3) to exclude 20 districts of State of Madhya Pradesh from consideration, deserves to be quashed and set aside in terms of this order. In other words, all applications received before the cut off date including of the respondent No.1 from concerned twenty districts of State of Madhya Pradesh ought to be treated as valid and eligible to participate in the consideration process. Indisputably, the petitioner had submitted such application in response to the notification on 30.06.2015, which is within the extended cut off date(i.e. 30.06.2015). In that, the fact that the petitioner had submitted application on 30.06.2015 has not been disputed. For that reason, respondent No.1 and other statutory Authorities will be obliged to decide the application preferred by the petitioner and take a final decision thereon expeditiously and not later than 3<sup>rd</sup> March, 2016. If any other application has been received from the districts which were otherwise excluded in terms of the impugned notification, within specified time, even those applications be processed by the respondent No.1 and other statutory Authorities in accordance with law before 3<sup>rd</sup> March, 2016 and decision thereon be communicated to the concerned applicants. If the decision is adverse to the concerned applicants, they will be free to challenge the same on grounds as may be permissible in law...".


In view of the above directions of the Hon'ble High Court, WRC in its 241<sup>st</sup> meeting held on February 4-6, 2016 directed the RD / WRO to take action on each such application received.

AND WHEREAS, the matter was placed before WRC in its 247<sup>th</sup> WRC meeting held on April 4-6, 2016 and the Committee observed that "...The institution is already running the B.Ed. course (223530) with two units. An examination of the file shows that the institution has not submitted the following :

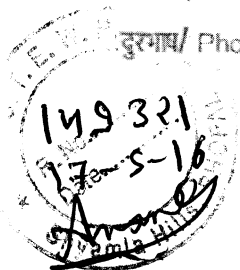
- No Objection Certificate from the affiliating body not submitted by the institution.
- Originally certified copy of land documents not submitted, only notarized copy submitted. Land area is 0.344 Hectares not sufficient. Diverted area is 0.324 hectares not sufficient. Built up area is 37230 Sq.fts
- Notarized Copy of Building Completion Certificate not submitted, only photocopy submitted.
- Notarized Copy of Non-Encumbrance Certificate not submitted, only photocopy submitted.
- Address of the society mentioned in the Registration of Society/Bye-laws not matching with the address mentioned in the application form.
- FDRs not submitted.

**Hence, Show Cause Notice be issued on the above grounds."**

Besides this, you are also hereby directed to re-submit the processing fee of Rs. 1,50,000/- DD No. 435662 dated 30.06.2015 for Rs. 1,50,000/- . The DD submitted by you is sent herewith for revalidation.


