SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, SAHAstra DHARA EDUCATION AND WELFARE SOCIETY, PLOT NO.13, STREET/ROAD - ITI ROAD, VILLAGE/POST OFFICE/TEHSIL/ TALUKA/TOWN/CITY/ DISTRICT - BALAGHAT, PIN CODE - 481001, MADHYA PRADESH had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition for D.El.Ed Course of 2 years duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 30.10.2015, 17.12.2015, and 08.01.2016 requesting to give their recommendation/comments.

AND WHEREAS, Rajya Shiksha Kendra, Bhopal, Madhya Pradesh vide letter dated 04.01.2016 has given their recommendation.


AND WHEREAS, the matter was placed before the WRC in its 242nd WRC meeting held on February 11-13, 2016 and the Committee observed that "...The institute has applied for the D.El.Ed. course. It is seen that the institution does not run any other course making it a standalone institution which is not permitted as per Clause 8(4) (i) of the per NCTE regulations, 2014. Further, it is seen that the NOC from the affiliating body has not been submitted. A photocopy of the rent agreement has been submitted which is not permitted under NCTE regulations, 2014. CLU, Building Completion Certificate, Non-Encumbrance Certificate, and FDRs have not been submitted. Photocopy of an unapproved Building Plan is submitted. Hence, Show Cause Notice be issued on the above grounds."

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 14(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
