SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, **SAMRIDDI SHIKSHA VIKAS EVM SWASTHYA SEVA SAMITI, PLOT NUMBER - 157, STREET/ROAD - INDORE - AHMEDABAD ROAD, VILLAGE/TOWN/CITY - GYANPURA, POST OFFICE - DHAR, TEHSIL/TALUKA - DHAR, TOWN/CITY - DHAR, DISTRICT - DHAR, PIN CODE - 454001, MADHYA PRADESH** had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition for D.El.Ed. Course of 2 years duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 30.10.2015, 17.12.2015, and 08.01.2016 requesting to give their recommendation/ comments.

AND WHEREAS, Rajya Shiksha Kendra, Bhopal, Madhya Pradesh vide letter dated 04.01.2016 has given their recommendation.

AND WHEREAS, the matter was placed before the WRC in its 240th WRC meeting held on January 20-22 2016 and the Committee observed that "...Although in the agenda notes it is mentioned that the applicant is not a composite institution, from the letter of the applicant it is seen that an application for B.Ed. has also been submitted by the applicant (APP3356). All such cases should be put up together by the WRO. An examination of the documents in both the files APP3541 and APP3356 show that the land is same. Although the applicant has sufficient area for B.Ed. and D.El.Ed, the NOC from affiliating body for D.El.Ed has not been submitted. This is necessary for the consideration of the case. There are some other lacuna also :-

- i) Originally notarized copy of Building Plan has not been submitted; and
- ii) BCC has also not been submitted.

Hence, Show Cause Notice be issued on the above three grounds."

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 14/15(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
