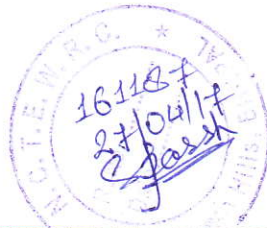

WRC/323067/B.Ed./2012/97762 dated 03.12.2012 issue to <u>the institution for de-affiliated from SNDD Womens University, Mumbai, Maharashtra</u> and thereafter, <u>affiliation of course with Saurashtra University, Rajkot, Gujarat.</u> A copy of order is enclosed.</p> <p>Institution is affiliated with <u>Saurashtra University, Rajkot, Gujarat.</u></p> <p>As the recognition of the institution has not been withdrawn by NCTE, it stands valid till date.</p>
