I am to refer to your letter dated 13.05.2013 on the subject. The Point wise information as provided by the concerned section is as under:-

1 & 2	<p>SWAMI VIVEKANAND MAHAVIDYALAYA, SAGAR, MADHYA PRADESH has been granted recognition for B.ED course (Code No- 223159) by WRC, NCTE.</p> <p>As the recognition of the institution has not been withdrawn by the NCTE, it stands valid till date.</p> <p>The institution has applied for change of affiliating body to Swami Vivekanand University. The matter was placed in 174th WRC meeting and it was decided as follows:-</p> <p>The letter dated 15.09.2012 of Prakar Pragya Shiksha Prasara Avam Samaj Kalyan Samiti was considered. The society has requested that its Colleges have become a University hence it be allowed to change its name from Swami Vivekanand Mahavidyalaya, Deendayal Nagar, Makroniya Education Building, Sagar (NCTE Code No. APW06843/225021) M.ED course to Swami Vivekanand University, Education Department, Sagar (M.P) Swami Vivekanand Mahavidyalaya, run by Prakar Pragya Shiksha Prasara Avam Samaj Kalyan Samiti Sagar, Code No. APW303741/223159 (addl) course B.ED to Swami Vivekanand University, Education Department Sagar, (M.P) and Swami Vivekanand Mahavidyalaya, Makroniya Sagar (M.P). It is noticed from the application of the Samiti that the address of the three Colleges is different from the address of the University. Therefore, it seems to be a case of shifting of premises, not of change of name Since the Samiti has not applied for shifting, the WRC is unable to take any decision on the Samiti's letter No. 705/ 2012 dated 15.09.2012. The fees submitted by the Samiti for change of name be returned. Accordingly, letter issued on 19.12.2012 (copy enclosed)</p>
