**WITHDRAWAL ORDER**

WHEREAS, recognition was granted to RAVINDRA COLLEGE, PANCHSHEEL NAGAR, SOUTH T.T. NAGAR, BHOPAL, PIN CODE – 462003, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting D.Ed. course vide order dated 16.06.2004 for an annual intake of 50 seats.

AND WHEREAS, Madhyamik Shiksha Mandal, Bhopal vide letter dated 02.08.2014 has informed that the institution is not running in the premises where Recognition was granted.

AND WHEREAS, the matter was placed before WRC in its 211<sup>th</sup> meeting held on October 31, 2014 and the Committee decided that Clarification Letter be issued to the institution asking to clarify on the issues raised by the State Government. Accordingly, Clarification Letter was issued on 10.11.2014.

AND WHEREAS, reply submitted by the institution on 14.11.2014 was placed before WRC in its 229<sup>th</sup> meeting held on July 21-22, 2015 and the Committee observed that "...This relates to complaint regarding functioning of the institution in different premises. The letter addressed to Principal/Director of the institution by the Secretary, Madhyamik Shiksha Mandal in this regard shows that the institution is not running in the premises where Recognition was granted. According to Regional Director, the office does not have any application for shifting of premises from the institution. Hence, Show Cause Notice be issued on the above grounds." Accordingly, Show Cause Notice issued on 30.07.2015.

AND WHEREAS, reply not submitted by the institution. The matter was placed before the WRC in its 253<sup>rd</sup> meeting held on May 24-26, 2016 and the Committee decided as follows "...Show Cause Notice was issued to the institution on 30/07/2015 on the ground that the WRO does not have any application for shifting of the premises. The institution is not functioning from the premises where Recognition was granted. The institution has not replied till date. **Hence, Recognition is withdrawn from the academic session 2016-2017.**"

NOW THEREFORE, the recognition granted to RAVINDRA COLLEGE, PANCHSHEEL NAGAR, SOUTH T.T. NAGAR, BHOPAL 462003, MADHYA PRADESH for conducting D.Ed. course vide order dated 16.06.2004 is hereby withdrawn under section 17(1) of the NCTE Act, 1993, **from the academic session 2016-2017.**

Further, if the institution is not satisfied by the order, it can prefer an appeal online to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi – 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
